Politically exposed person: a natural person who is entrusted with prominent public functions, or who has been entrusted with prominent public functions within one year before the implementation of customer due diligence measures².

A) Persons entrusted with prominent public functions:

a)	heads of State, heads of government, ministers, deputy ministers, state secretaries, in Hungary the head of State, the Prime Minister, ministers and state secretaries
b)	members of parliament or of similar legislative bodies, in Hungary members of parliament and spokesmen for nationalities
c)	member of the governing body of a political party, in Hungary member or officer of the governing body of a political party
d)	members of supreme courts, of constitutional courts or of other high-level judicial bodies, the decisions of which are not subject to further appeal, in Hungary members of the Constitutional Court, of the courts of appeal and the Curia
e)	members of courts of auditors or of the boards of central banks, in Hungary the President and Vice-President of the State Audit Office, members of the Monetary Council and the Financial Stability Board
f)	ambassadors, chargés d'affaires and high-ranking officers in the armed forces, in Hungary the head of the central body of law enforcement bodies and organizations and his deputy, Chief of Staff of the Hungarian Army and Deputy Chiefs of Staff of the Hungarian Army
g)	members of the administrative, management or supervisory bodies of enterprises with majority state ownership, in Hungary the managing directors of enterprises with majority state ownership, including members of the management body exercising control or supervisory rights of such enterprises
h)	directors, deputy directors and members of the board or equivalent function of an international organization

B) Immediate family members of a politically exposed person:

a)	spouse
b)	domestic partner
c)	biological and adopted children, stepchildren and foster children
d)	spouses and domestic partners of the above
e)	biological, adoptive, step- and foster parents

C) Persons known to be close associate of a politically exposed person

a)	any natural person who is known to have joint beneficial ownership of legal entities or unincorporated organizations, or any other close business relations of the politically exposed person
b)	any natural person who has sole beneficial ownership of a legal entity or unincorporated organization which is known to have been set up for the benefit of a politically exposed person
